**Subject:- Skill Development Programme under Champion Services Sector Scheme – regarding.**

Respected Sir,

Ministry of AYUSH has developed '*Central Sector Scheme under Champion Services Sector Scheme*' with component of skill development. Twelve types of courses of different duration are proposed under this scheme. Financial assistance of Rs. 9000/- per month per person is also proposed for the trainees and upto three lakhs to the training institute for running the course, for giving remuneration to the trainers and for other miscellaneous expenses.


Some of the courses are for fresh graduates and some are for 12th passed students. The proposed duration of different courses ranges from 30 days to 90 days. Normally, each batch shall consist of 30 trainees at a time but not exceeding 55 trainees every batch in any case.

The purpose of this scheme is to developed AYUSH specific skilled human resource, capacity building of existing skilled human resources, to promote export of services with the help of the skilled manpower and to develop supporting structure for AYUSH health services.

The institutes/colleges having permission for last three consecutive academic years from CCIM/NCISM are eligible for this scheme. The details of the scheme is attached herewith. You may visit Ministry of AYUSH website for further details.
