Sir/Madam,

This is to inform you that the process of visitation of ASU colleges for the academic session 2024-25 has been commenced. The section 29 (7) of the National Commission for Indian System of Medicine Act, 2020 states that:-

"The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution."

Further, MARBISM is in the process of preparing the pool of visitor's for the upcoming visitation. You are hereby directed to suggest the names of eligible visitors among the faculty of your institution.

The integrity and experience in medical profession along with readiness to maintain the confidentiality of the visitation process and ability to assess the institution in an unbiased manner are most important criteria apart from the criteria mentioned below.

- 1. Minimum 05 years teaching experience after PG (Post Graduation)
- 2. Teacher should possess administrative experience as HOD/Medical Superintendent, Deputy Medical Superintendent or Nodal Officer for apex body matters.
- 3. Earlier visitation Experience if any.

Further, it is to be noted that the Board will randomize the visitors among the list provided by the institutions. Further addition or deletion of the teachers to this list is solely under the discretion of the Board.

Hence, you are hereby requested to fill E-form through your College Login on NCISM portal and recommend the Teachers with the limit of maximum up to 15 for the purpose of visitation for the academic year 2024-25 within 3 days with an intimation to the Medical Assessment and Rating Board, National Commission for Indian System of Medicine through e-mail (president.marbism@ncismindia.org).
